# Europe needs to step up circular economy efforts: EU agency

EU agency warns that Europe needs to step up its circular economy efforts to meet its environmental and climate targets. While some progress has been made, such as reducing landfill waste, more momentum is needed to completely transform production and consumption patterns towards circularity and sustainability. "Decisive action is essential to drastically reduce waste, prioritise reduction of resource use, improve recycling rates and improve the introduction of products that are designed for circularity from the outset," the Copenhagen-based agency said in a statement presenting a new report.

### <u>EU agrees US deal to launch satellites with Elon Musk's</u> <u>SpaceX</u>

The European Union signed a security agreement with the United States to launch satellites using Elon Musk's SpaceX rockets. This agreement gives the EU access to US space launches and strengthens transatlantic cooperation on security and space technology, in a context of increasing global competition in space. "The cancellation of two Soyuz launches from the Guiana Space Centre in April and September 2022 as well as the announced delay of Ariane-6 force the Union to find alternatives to resume urgently the launches of Galileo satellites," the text of the EU's security pact with the U.S. This

leaves Space X as the only viable alternative

### <u>Lobby groups call for business-friendly turn of the EU Green</u> <u>Deal</u>

Pressure groups leaded by The EU's main business lobby, BusinessEurope, and the German Chamber for Industry and Commerce (DIHK) are calling on the EU to adopt a more businessfriendly approach in its "Green Pact", arguing that current environmental policies could harm economic competitiveness and employment. They advocate measures that incentivise innovation and private investment in sustainable technologies, while minimising regulatory burdens on business. focusing on the fact that it should be better explained to companies what is required from them calling for reducing double reporting.
